78 Q: Okay. And the reason I'm here is because I - I - if that's happened I want you
79 to know this is a safe time to tell me about that.

84 details.

92 Q: Have you heard of the staff intimidating anyone to not provide statements?

98 documented. I just needed to ask you those three simple questions.
