## I. Call to Order (Chief Ngo)

## IV. SIU Update (Summer Ogle)

Summer gave updates on the Sheriff's Identification Unit (SIU) that were highlighted in the 2022 Annual Report. This included the Fingerprint Identification Director position, the Latent Fingerprint Examiner Supervisor position, team highlights, promotions, the hybrid workplace, ANAB accreditation, cold case highlights, case statistics, and Automated Fingerprint Identification System (AFIS) database growth.

Summer also explained the difference between "print areas" and "latents." One print area can contain numerous latents.

# V. Technology Update (Leslie Chan)

Leslie gave an update on the technology highlighted in the 2022 Annual Report to include the new fiber optic direct line, the Mobile ID replacement project, and SIU hardware replacement.

## VI. Financial Report (Thuyet Dang)
