TYPE OF INCIDENT: Sexual Assault Identification

LOCATION: Stevens Creek Boulevard at North Stelling Road, Cupertino

CASE NUMBER: 21-125-0237C

DETAILS:

The Sheriff's Office is asking for the public's assistance on any information leading to the identification of a suspect involved in a sexual assault investigation in the city of Cupertino:

On 05/05/2021, a female adult who is legally blind was walking to her workplace in the area of Stevens Creek Boulevard at North Stelling Road, city of Cupertino.

Prior to the assault, an unknown male suspect approached the female victim as she was walking and made verbal flirtatious advances towards her. The female victim politely declined and continued to walk to her workplace.

The unknown suspect later re-approached the female victim at an outdoor public parking lot, in broad daylight. The suspect held the legally blind victim against her will and sexually assaulted her. Based on the timeframe of the encounters, it appeared the suspect was following the female victim prior to the assault.

After being approached by a witness, the suspect immediately ran away on foot through the parking lot and later fled in his vehicle. The suspect and vehicle is described as followed:

- Hispanic, male adult
- Approximately 20-30 years old
- 5'10" - 6'00" tall
- 200-240 lbs

Vehicle Description:

- 2003-2007 Scion XB
- Color: Silver
- No front license plate
- Colorful objects which appear to be model cars on the dashboard of the vehicle
