


# Sheriff's Office Custody Bureau Inmate Grievances Dashboard March 2023


Historical ACeS Grievance Volume Apr 2022 through Mar 2023



The data above compares the volume of monthly grievances for the last 12 months. For comparison, the data is separated by each of our three jail facilities: Main Jail North, Elmwood Men's Facility and Elmwood Women's Facility (CCW), and also by "Other - Out of Facility" areas. This refers to areas such as the Courts or Alternative Supervision programs.

For the month of March, the Sheriff's Office experienced a 63.4% increase in grievance submissions or 315 more grievances than the previous month. Individually, the Main Jail Facility increased by 62.2%, the Elmwood Men's Facility by 54.4% and the Elmwood Women's Facility by 81.4%. A large majority of the upsurge was due to an isolated incident regarding learners' credits on the inmate tablets. Additional information will be available on the following slide.

Top Five Most Frequent Grievance Categories March 2022 vs. March 2023




The data above compares the current month's Top Five Most Frequent Grievance Categories against the same month from a year ago.

The Most Frequently Grieved Category for the month of March was "Technology."

As shown above, the "Technology" category experienced a 157.4% increase in grievance submissions from the same period last year and a 717.7% increase when compared to the previous month. At the beginning of March, a clerical error occurred which mistakenly added 50,000 points to most user accounts on the educational software application on the inmate tablets. Once the discrepancy was discovered, the points were removed, but the actions affected ALL learners on the platform.

Inmates submitted grievances complaining about the sudden increase in points followed by its disappearance. Within 24 hours of receiving these complaints, our vendor was able to restore the credits back to what the learners' totals were before the rapid increase in points. To help reduce frustration among the inmate population, our vendor sent a message to all affected learners advising them of their plan of action and also provided an additional 100 points to everyone's account. Inmates accrue points by participating in educational programs on the tablets. In turn, inmates are able to use the points for entertainment content on the tablets like watching movies, playing games, or listening to music.


Main Jail Total Grievances vs. Average Daily Population APR '22- MAR '23



The data above compares the total inmate grievances submitted by month for the last 12 months at the Main Jail Facility.

In March 2023, there were 206 grievances submitted by Main Jail inmates with an average daily population of 761 inmates. This would equate to 0.27 grievances submitted per inmate in the month of March. In actuality, only 111 inmates from Main Jail submitted grievances in the month of March.


### Elmwood Men Total Grievances vs. Average Daily Population APR '22- MAR '23



The data above compares the total inmate grievances submitted by month for the last 12 months at the Elmwood Men's Facility.

In March 2023, there were 372 grievances submitted by the Elmwood Men inmates with an average daily population of 1,889 inmates. This would equate to 0.20 grievances submitted per inmate in the month of March. In actuality, only 261 inmates from Elmwood Men's submitted grievances for the month of March.

Elmwood Women Facility Total Grievances vs. Average Daily Population APR '22- MAR '23




The data above compares the total inmate grievances submitted by month for the last 12 months at the Elmwood Women's Facility.

In March 2023, there were 234 grievances submitted by the Elmwood Women inmates with an average daily population of 292 inmates. This would equate to 0.80 grievances submitted per inmate in the month of March. In actuality, only 94 inmates from Elmwood Women's submitted grievances for the month of March.

## Grievance Totals by Category and Facility

MARCH 2023 Grievances 812 + 176 Inmate Requests + 57 Positive Comments



The above data shows all the inmate grievances submitted for the month of March 2023 by grievance category. The chart also depicts the number of inmate grievances by location; Main Jail North, Elmwood Men's, Elmwood Women's (CCW), and out-of-facility locations (such as Courts).

The Top 5 Most Frequent Grievance Categories accounted for 55% of all submitted grievances for March 2023. All other categories sum up the remaining balance or 45% of all grievances for the month of March. The "Jail Crimes" category had the lowest grievance count for the month of March with 1 (one) submission.

The chart below ranks the frequency of inmate grievances submitted by category for March 2023. This data aids the Office of the Sheriff in focusing attention on specific issues raised by the inmate population. Certain categories reported the same total number of grievances as another category, so there are several ties in the frequency ranking system for the month of March.

A year ago, the "Commissary" category was the 2<sup>nd</sup> Most Frequently Grieved Category, but last month it was ranked as the 5<sup>th</sup> and experienced a 48.5% decrease in submissions. Last month, it was reported that our vendor successfully deployed digital capturing devices in all three facilities to help streamline the commissary distribution process. Since all records will be stored digitally in our vendor's accounting software, grievance complaints will be easier to resolve, and in some instances, our vendor can issue credits during the distribution process instead of days later once the paper receipts are received.

The deployment of the hand-held devices last month not only increased efficiency for staff and inmates alike, it was also a precursor for our vendor to resume their full commissary distribution duties with pre-pandemic expectations. At the beginning of the pandemic, the commissary program was temporarily suspended and once it was resumed, our deputies were tasked with absorbing the vendor's roles and responsibilities with the commissary distribution process. Having our vendor reinstitute their obligations at the beginning of March allowed the Sheriff's Office to shift the staffing efforts to increase inmate programming and out-of-cell activity.

NOTE: The two categories, "Inmate Requests" and "Positive Comments," have been added to this report, but they are not considered true grievances
